Important Notice: Dealing Suspension of Certain Investment Choice(s) under Manulife Investment Plus ("MI Plus") / Manulife Investment Solutions ("MISo") / Alpha / Alpha Regular Investor ("ARI") / Matrix

Due to the bank holiday in Ireland and the closure of the stock exchanges in Singapore for the public holiday, the relevant underlying funds will have no valuation to provide and the valuation and dealing of the following corresponding investment choices (collectively, the "Investment Choices") will be suspended.
