

Manager's Comments

US stocks rose strongly, with the S&P500 Index breaking through the 5,000 level to reach a fresh record high, whilst the Nasdaq Composite Index also surpassed its previous high set in November 2021. Solid corporate earnings, a resilient US economy and a further surge in Al-related stocks all drove the market higher, with growth stocks outperforming value ones by around 3% over the month. US bonds recorded negative returns as hopes of a cut in US interest rates in March faded. The 10-year Treasury bond yield rose around 30 basis points (bps) over the month and traded above 4.3%, a level last seen in early December. With yields increasing even more in the short end of the curve, the yield curve became more inverted, although it remained well below the extreme inversion levels seen in mid-2023.

基金經理評論

美國股市急升,標準普爾500指數突破5,000點水平,創歷史新高,而納斯達克綜合 指數亦超越2021年11月所創的高位。企業盈利強勁、美國經濟穩健及人工智能相關 股票進一步上漲,均帶動市場上升,增長股在月內表現優於價值股約3%。由於美 國於3月份減息的希望消退,美國債券錄得負回報。10年期美國國庫券收益率在月 内上升約30點子至4.3%以上,為去年12月初以來最高水平。由於短期債券收益率 升幅更大,收益率曲線倒掛的情況加劇,但仍然遠低於2023年中出現的極端倒掛水
